

Privacy Policy

WHAT INFORMATION DO WE COLLECT?

Like most website operators, Kirinzan Brewery collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Kirinzan Brewery's purpose in collecting non-personally identifying information is to better understand how Kirinzan Brewery's visitors use its website. From time to time, Kirinzan Brewery may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Kirinzan Brewery also collects potentially personally-identifying information like Internet Protocol (IP) addresses for users leaving comments on kirinzan.co.jp blogs/sites. Kirinzan Brewery only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

WHAT DO WE USE YOUR INFORMATION FOR?

Certain visitors to Kirinzan Brewery's websites choose to interact with Kirinzan Brewery in ways that require Kirinzan Brewery to gather personally-identifying information. The amount and type of information that Kirinzan Brewery gathers depends on the nature of the interaction. For example, we ask visitors filling out the Contact form at kirinzan.co.jp to provide their name, business name, and email address. Those who engage in transactions with Kirinzan Brewery are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Kirinzan Brewery collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Kirinzan Brewery. Kirinzan Brewery does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

AGGREGATED STATISTICS

Kirinzan Brewery may collect statistics about the behavior of visitors to its websites. Kirinzan Brewery may display this information publicly or provide it to others. However, Kirinzan Brewery does not disclose personally-identifying information other than as described below.

HOW DO WE PROTECT YOUR INFORMATION?

Kirinzan Brewery discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need

to know that information in order to process it on Kirinzan Brewery's behalf or to provide services available at Kirinzan Brewery's websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Kirinzan Brewery's websites, you consent to the transfer of such information to them. Kirinzan Brewery will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Kirinzan Brewery discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Kirinzan Brewery believes in good faith that disclosure is reasonably necessary to protect the property or rights of Kirinzan Brewery, third parties or the public at large. If you have supplied your email address, Kirinzan Brewery may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Kirinzan Brewery and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Kirinzan Brewery takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

DO WE USE COOKIES?

Kirinzan Brewery uses cookies to help Kirinzan Brewery identify and track visitors, their usage of Kirinzan Brewery website, and their website access preferences. Kirinzan Brewery visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Kirinzan Brewery's websites, with the drawback that certain features of Kirinzan Brewery's websites may not function properly without the aid of cookies.

PRIVACY POLICY CHANGES

Although most changes are likely to be minor, Kirinzan Brewery may change its Privacy Policy from time to time. Any changes will updated in this document.
